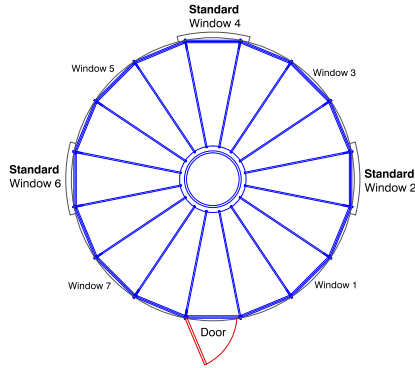

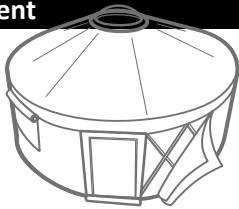

Shipping. Shipping charges are additional. I understand that I am responsible for transportation and all costs associated with shipping my Yurta to its final destination. Customer is responsible for any additional duties, customs clearing or additional transportation-related charges.

I understand that I will hold harmless, indemnify, and release Namasci Inc. from any and all liability and accidents that may occur from any and all use of the Yurta. Namasci Inc. reserves the right to update and change terms from time to time at its sole discretion.
